Also enclosed is a photocopy of the notes which were in the possession of SALVATORE TORNABE on 11/14/57. This was received on 3/10/58, by the NYO from the Bureau.

Regarding the Lexington Hotel records, a review of the files of the NYO reflects that no original record of JAMES LADUCA's stay at that hotel is in the possession of the NYO. It is noted that on 3/7/58, the NYS Liquor Authority had in its possession Lexington Hotel records regarding LADUCA's stay there from 11/7/57, to 11/12/57.

> A review of NYO files failed to reflect possession by the NYO of any registration cards listed in enclosure to reBulet for the New Yorker Hotel. It is noted that on 1/17/58, EDWARD FORD, Assistant Credit Manager of the hotel, furnished information regarding the stay of FRANK DESIMONE and SIMONE SCOZZARI from 11/11/57, to 11/15/57, to SA JAMES M. BEARDSLEY from these records.

> NYO files further reflected that no registration cards from the Forrest Hotel as set forth in above mentioned enclosure are in the possession of the NYO. On 3/25/58, PCI LILLIAN WILLIAMS, telephone operator at the Forrest Hotel, advised SA JOSEPH F. WICKMAN that RUSSELL BUFALINO and ANTHONY GUARNIERI were at the hotel the weekend of 3/17/58.

On 1/27/58, Miss V. DUNN, Auditor, advised SA JAMES P. MANSFIELD that the only record she could locate regarding GUARNIERI was a registration for 12/27/57. stated that her records had been borrowed by a team of men from the Mc Clellan Committee who had visited her office a week earlier and secured information pertaining to persons recently identified with the Apalachin meeting.

On 1/22/58, JOSEPH ROONEY, Manager, stated he could locate no record for SCOZZARI or DESIMONE. On 7/9/58, ROONEY advised SA EDWARD F. FOLEY that BUFALINO, GUARNIERI, ANGELO SCIANDRA and DOMINIC ALAIMO had been in the hotel in the past.
