PAUL RENNARD stated he flew JAMES TEDESCO, an officer in the Sullivan Trail Company, and WILLIAM MEDICO, to Bridgeport, Connecticut on November 14, 1957. He said MEDICO owns a factory in the Bridgeport area and was trying to sell it to LOUIS PAGNOTTI. He said he flew on instrument that day and remained at the Bridgeport airport while MEDICO and TEDESCO went about their business. He stated he did not fly to either Endicott or Binghamton on November 14, 1957. He also stated his own private log reflected the same departure and arrival times as reflected in the CAA records.
