SUBJECT: CRIMINAL INFLUENCE IN LABOR  
ORGANIZATIONS - CRIMINAL  
INTELLIGENCE PROGRAM

The following is furnished for the information of the Bureau and Newark:

New York PCI ~~NICHOLAS KISBURG~~, former Public Relations Director for ~~ANTHONY PROVENZANO~~, and presently employed by ~~JOHN O'Rourke~~, President of Teamsters Joint Council 16, New York, advised that ~~ANTHONY CASTELLITTO~~, Secretary-Treasurer, International Brotherhood of Teamsters (IBT), Local 560, Union City, New Jersey, who is presently missing, was a bitter enemy of ~~PROVENZANO~~.

PCI advised that ~~CASTELLITTO~~ was put into Local 560 by the "Charlie Yanowski pier mob". He said that ~~YANOWSKI~~ was murdered in New Jersey some time ago, but ~~CASTELLITTO~~ was still under obligation to ~~YANOWSKI~~'s associates. This informant advised that ~~PROVENZANO~~ resented ~~CASTELLITTO~~ because of his connections with the "Jewish mob" and the hard feelings between the two reached its peak during the last elections held in Local 560. Informant advised that ~~CASTELLITTO~~ waged his own campaign and made no effort to insure ~~PROVENZANO~~'s election.

Informant speculated that ~~CASTELLITTO~~ may have been liquidated by henchmen of ~~PROVENZANO~~ or ~~YANOWSKI~~ since ~~CASTELLITTO~~ was the type of individual who would "double-cross anybody".

For the information of the Bureau, informant stated that the rift between ~~JOHN O'Rourke~~ and ~~JAMES HOFFA~~ has widened considerably and there appears to be little change of reconciliation between the two. Informant stated that at the
