During the period 8/9 through 8/12/61, no pertinent telephone calls were charged to credit card number 752-2735-42. It should be noted that this credit card number is reflected in the records of the New York Telephone Company as 752-2735-L 12, issued to PHYLLIS MC GUIRE, 525 Park Avenue, New York, New York, subscriber to PL 2-2735, a non-published number *u*

The following calls were charged to MC GUIRE's credit card and are probably pertinent to her relationship with subject: *u*

Numerous other calls were made during the period from 7/13 to 9/3/61, charged to MC GUIRE's credit card number. These calls were to PHYLLIS MC GUIRE's home in New York City; her parent's home in Miamisburg, Ohio; her sister's home in Fitzwilliam, New Hampshire; to DAN ROWAN, PHYLLIS' reputed boyfriend, as well as to known business associates of PHYLLIS MC GUIRE in New York, Florida and California. There is no indication the subject used PHYLLIS MC GUIRE's credit card for calls made by him, according to available records. U

PCI RANDY BURKE advised on 10/11/61, that the MC GUIRE sisters are to depart New York City for London, England, via BOAC flight 684 at 8:30 p.m. on 10/12/61, arriving London at 8:45 a.m. 10/13/61. He had no knowledge whether subject would also accompany them, but will remain alert for this possibility. U

It is being left to the discretion of the office of origin to determine necessity of notifying Legat, London re association of subject with PHYLLIS MC GUIRE and possibility of his being with her during the London engagement of the trio. U
