SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY. PCI SUSAN TROOST, ADVISED  
YESTERDAY THAT SAM GIANCANA HAS DELEGATED CHARLES QUOTE "CHUCK" UNQUOTE  
NICOLETTI AS HIS PERSONAL EMISSARY OF CICERO, ILLINOIS, AND IN THAT  
CAPACITY CONTROLS ALL GAMBLING ACTIVITY IN THAT AREA. DIRECTLY UNDER  
NICOLETTI IS FRANK SHARKEY EULO AND JOSEPH QUOTE "PEPE" UNQUOTE GIANCANA,
