SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. JASPER PELLICANE
CONTACTED THIS DATE IN VICINITY OF RIVIERA LOUNGE, NILES, ILL., BY
BUAGENTS. NOTED THAT RIVIERA IS OPERATED AS PART OF GIANCANA-S
HOLDINGS BY ROCCO POTENZO. GAMBLING STAMP ISSUED IN THE NAME OF
JASPER PELLICANE. PCI HENRY NODL HAS ADVISED THAT PELLICANE OPERATES
BOOKMAKING SECTION OF RIVIERA FOR POTENZO. PELLICANE STATED DURING
INTERVIEW THAT HE IS A BOOKMAKER, HAS BEEN A BOOKMAKER ALL OF HIS LIFE,
AND OPERATES THE RIVIERA AS AN INDEPENDENT. ADMITTED KNOWING
POTENZO, COULD NOT RECALL POTENZO-S WHEREABOUTS AT TIME. NOTED THAT
POTENZO-S AUTO, A SIXTY ONE OLDS CONVERTIBLE, WAS PARKED AT CURB
DURING INTERVIEW. THIS WAS POINTED OUT TO PELLICANE, WHO CONTINUED
TO DENY KNOWING POTENZO OTHER THAN ON A CASUAL BASIS. ASKED ABOUT
GIANCANA AND STATED THAT HE DOES NOT KNOW HIM, AND HAS NEVER HEARD
OF HIM, EXCEPT FROM PAPERS. PELLICANE WAS PRESSED FOR FURTHER DETAILS
RE OPERATION OF THE RIVIERA, AND STATED QUOTE IF YOU GUYS WANT TO
PRESS ME FURTHER, ALL HAVE TO SEE MY LAWYER END QUOTE...
