CG 6486-C* REPORTED OVER WEEK END OF SEPTEMBER LAST THAT GIANCANA AND CREW WERE IN ATTENDANCE AT VICINITY OF INFORMANT, HOWEVER, MOSTLY RELATED TO DINNER PARTY ACTIVITY, AND NOTHING OF PERTINENCE WAS NOTED. (u)

CG 6486-C* REPORTED SEPTEMBER 17-18 LAST ONLY ACTIVITY WAS PRESENCE OF DOMINIC BLASI AND TARQUIN SIMONELLI, LOOKING OVER BILLS OF ARMORY LOUNGE, AND COMPLAINING THAT INDIVIDUALS SUCH AS JOHN FORMUSA, ET AL, ARE BEING SUPPLIED WITH FOOD AND BEVERAGE ON THE HOUSE WHEN THEY CAN WELL AFFORD TO PAY. (u)

PCI GEORGE VYDRA REPORTED SEPTEMBER 17 LAST ON PROGRESS RELATING TO THE ENGLISH BROTHERS TAKING OVER INFORMANT'S SINGER, JANE DARWYN, STATED HE IS SCHEDULED FOR MEETING INSTANT AT EXECUTIVE HOUSE, CHICAGO, WITH CHARLES AND SAM ENGLISH, AND SAM GIANCANA, ALONG WITH REPRESENTATIVES FROM PLAZA RECORD COMPANY, LOS ANGELES.
