Potential CRIMINAL INFORMANT

PCI GEORGE VYDRA ADVISED INSTANT THAT HE MET WITH CHARLES AND SAM ENGLISH AT THE FIFTH JACK CLUB, CHICAGO, SEPTEMBER SEVEN LAST. NOTED THAT THE ENGLISHES ARE CHICAGO TOP HOODLUMS. CHARLES ENGLISH OPERATES LORMAR RECORD DISTRIBUTORS, CHICAGO, AND IS GIANCANA LIEUTENANT AND BUSINESS PARTNER. PURPOSE OF PCI MEETING WITH ENGLISHES WAS FOR PUSHING INFORMANT-S SINGER, JANE DARWIN, AS RECORDING STAR. INFORMANT HAS STATED HE HAS ASCERTAINED NO ONE CAN ATTAIN ^{Success} ~~SUCCESS~~ IN JUKE BOX FIELD IN CHICAGO AREA WITHOUT SANCTION OF ENGLISH. DURING CONFERENCE WITH ENGLISHES, PCI WAS ADVISED BY THEM THAT CHARLES ENGLISH OWNS NINETY PER CENT OF PLAZA RECORDS, AND MAINTAINS ABSOLUTE CONTROL OF JUKE BOXES AND RECORDS PLAYED ON THEM. (u)

ENGLISH WAS IMPRESSED BY INFORMANT-S SINGER AND DESIRED HER TO BE HEARD BY GIANCANA. ON SEPTEMBER EIGHT LAST, INFORMANT-S SINGER APPEARED AT WEDDING RECEPTION HELD AT PALMER HOUSE HOTEL WHICH WAS ATTENDED BY, ACCORDING TO INFORMANT, MOST OF CHICAGO-S HOODLUMS, INCLUDING GIANCANA, WHO WAS WITH CHARLES ENGLISH. GIANCANA WAS IMPRESSED BY INFORMANT-S SINGER AND AGREED THAT SHE SHOULD BE HANDLED THROUGH PLAZA RECORDS.
