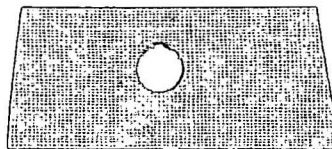
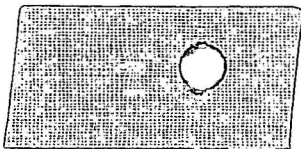

SAMUEL M. GIANCANA, AKA., AR. DAILY SUMMARY.

CG 6533-C ADVISED SEPTEMBER 18 LAST GIANCANA OBSERVED ENTERING ARMORY LOUNGE. AT SAME TIME, CHARLES AND SAM ENGLISH, CHICAGO TOP HOODLUMS, OBSERVED ENTERING ARMORY DURING PHYSICAL SURVEILLANCE CONDUCTED ON THEIR ACTIVITIES FROM LORMAR DISTRIBUTORS. NOTED THAT PCI GEORGE VYDRA ADVISED SAME DATE HE WAS SCHEDULED TO MEET WITH THE ENGLISHES AND GIANCANA AT EXECUTIVE HOUSE HOTEL SEPTEMBER 18 LAST. (u)

CG 6486-C* ADVISED SEPTEMBER 18 LAST THAT GIANCANA SPENT ENTIRE AFTERNOON AND NIGHT OF THAT DATE AT ARMORY LOUNGE, HOWEVER, DID NOT CONDUCT BUSINESS DISCUSSIONS. ONE CONFERENCE OF NOTE WAS FACT THAT JAMES CELANO, THE TAILOR AND OCCUPANT OF PREMISES UNDER CONTROL OF CG 6343-C*, CONFERRED WITH GIANCANA CONCERNING A FAVOR HE DESIRED OF GIANCANA. DURING DISCUSSION, CELANO DESCRIBED HIS INTERVIEW BY FBI AGENTS AND SAID THAT HE THREW THE AGENTS OUT OF HIS OFFICE. GIANCANA WAS NOT IMPRESSED.
