DAILY SUMMARY. CG 6486-C\* ADVISED THAT ON SEPTEMBER 20 LAST, FIORE BUCCIERI, ALLEGED NUMBER TWO MAN TO GIANCANA, HELD DISCUSSION WITH UNKNOWN, POSSIBLY DAVE YARAS, MOST OF WHICH WAS NOT DISCERNIBLE, MENTIONED SOMETHING ABOUT CASHING CHECKS, AND A NEW APARTMENT WHICH IS TO BE UTILIZED BY THEM, LOCATION UNKNOWN. (u)

PCI GEORGE VYDRA WAS IN NEW ORLEANS OVER PAST WEEKEND, AND HAS ADVISED THAT GIANCANA, THROUGH CHARLES ENGLISH, MAINTAINS ABSOLUTE CONTROL OVER THE JUKE BOX AND ENTERTAINMENT FIELD IN THAT AREA. INFORMANT WILL FURNISH FULL REPORT WHICH WILL BE ELABORATED UPON WHEN RECEIVED. (u)
