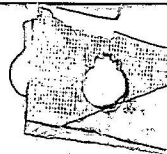
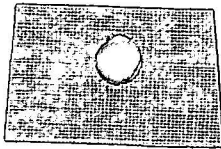

RE CHICAGO IRADIX OCTOBER TWO LAST.

PHOENIX OFFICE SHOULD CONDUCT APPROPRIATE INVESTIGATION TO DETERMINE IF SAM ENGLISH, MIKE SABATINO AND GEORGE VYDRA STAYED AT THE SAFARI MOTEL, PHOENIX, SEPTEMBER TWENTY-SIX LAST. PHOENIX SHOULD ALSO ATTEMPT TO IDENTIFY RANCH DESCRIBED BY CHICAGO PCICAS BEING NEAR RIMROCK, ARIZONA. HOWEVER, YOU MUST INSURE THAT NO INVESTIGATION IS CONDUCTED WHICH WOULD ALERT SUBJECT OR HIS ASSOCIATES. CHICAGO OFFICE OBTAIN DETAILED INFORMATION FROM PCI VYDRA RELATIVE TO LOCATION OF THE RANCH, INCLUDING LANDMARKS, AND IMMEDIATELY FURNISH INFORMATION TO PHOENIX. PHOENIX MUST VIGOROUSLY PURSUE THIS MATTER AND ADVISE BUREAU BY OCTOBER TEN NEXT RESULTS OF INVESTIGATION.

NOTE: PCI of Chicago Office made trip to Phoenix with Sam English and Mike Sabatino, lieutenants of prominent Chicago hoodlum Giancana. PCI reported that he traveled with these individuals to a ranch 93 miles east of Phoenix near Rimrock. Informant counted nine unidentified individuals staying at ranch home who were described as "hiding out." Phoenix instructed to verify presence of Giancana's lieutenants at Safari Motel and to attempt to identify ranch described by informant without alerting to Bureau interest.
