2 DAILY SUMMARY. CG 6486 - C\* ADVISED OCTOBER 2 LAST THAT DOMINIC BLASI RECEIVED SEVERAL CALLS IN WHICH UNIDENTIFIED CALLER ADVISED BLASI "ENVELOPES WERE READY". UPON EACH INSTANCE, BLASI MADE ARRANGEMENTS TO MEET INDIVIDUAL TO COLLECT ENVELOPE, INDICATING THAT BLASI, IN ABSENCE OF GIANCANA, MAKES MONTHLY COLLECTIONS. ACCARDO, JACK CERONE, AND BERNARD GLICKMAN APPEARED FOR SHORT TIME IN VICINITY OF SOURCE, PARTICIPATED IN CARD GAME. INDICATES POSSIBILITY THAT CERONE AND OR ACCARDO ARE RECIPIENTS OF SOME OF THE ENVELOPES. (u)

PCI GEORGE VYDRA ADVISED THAT SAM ENGLISH DESIRES TO PLACE SLOT MACHINES IN ELK LODGE, BERWYN OF WHICH INFORMANT IS EXALTED RULER. INFORMANT INTENDS TO CARRY THROUGH ON THIS AND KEEP ACCURATE RECORDS OF AMOUNTS DISBURSED TO ENGLISH BROTHERS FROM THIS ENTERPRISE. (u)
