POTENDIAL CONFIDENTIAL INFORMANT. DAILY SUMMARY. PCI GEORGE VYDRA REPORTED OCTOBER 1 LAST REGARDING HIS RECENT TRIP TO PHOENIX, ARIZONA WITH SAM ENGLISH AND MIKE SABATINO, BOTH GIANCANA LIEUTENANTS. INFORMANT ARRIVED PHOENIX SEPTEMBER 26 LAST, MET AT AIR-PORT BY JOSEPH ENGLISH, BROTHER OF SAM, DROVE 93 MILES EAST TO A RANCH NEAR RIMROCK, DRIVING ON BACK ROADS. ADVISED INFORMANT HE OWNS PROPERTY NEXT TO AMATO IN TUSCON.
