On 11/6/63, PCI LOWELL WILLIAMSON advised that BEN SWIFT of Fort Lauderdale, Florida, and CHRISTINE MC GUIRE visited him and DOROTHY MC GUIRE (wife of PCI) in Calgary, Canada.

SWIFT and CHRIS MC GUIRE advised PCI that GIANCANA had stated that PORFIRIO RUBIROSA had a photograph purportedly showing RUBIROSA in a compromising position with PAT LAWFORD, the wife of PETER LAWFORD, the movie actor. GIANCANA indicated he was trying to obtain this photo and if successful this would "solve all of my problems" with the government.

PCI advised this is undoubtedly the reason GIANCANA was talking about going to Paris, France, and PCI had mistakenly thought GIANCANA was going for gambling reasons.

Miami will not interview PCI BEN SWIFT concerning the above, UACB.
