ROBERT MEISSNER APPEARED AT CHICAGO OFFICE AFTER HE MET JOSEPH VERHELLE IN CHICAGO TODAY. VERHELLE DID NOT IDENTIFY POTENTIAL DEFENSE WITNESS IN CHATTANOOGA TRIAL BUT GAVE IMPRESSION SOMEONE WOULD TESTIFY REGARDING PUBLIC BANK OF DETROIT SITUATION TO SHOW THE GOVERNMENT GOING ALL OUT AGAINST HOFFA.
