## SYNOPSIS OF FACTS:

On 7/30/56, 32,800 lbs. gambling equipment shipped by NORMAN ROTHMAN, Chicago, Ill., to NORMAN ROTHMAN, Miami, Fla. Equipment arrived Miami 8/3/56, and was located at Tamiami Tours, Inc., Transport Co. Equipment was to be shipped to ALBERT ARCURA, Tropicanna Night Club, Havana, Cuba. Examination of equipment failed to reflect any markings whatsoever on any of the parts of the gambling machines. No machines were found to be completely in tact, no mechanical parts of the machines were located. Shipment consisted of 470 slot machine metal cabinets with handles, 299 slot machine frames, 24 drums of slot machine parts, and 5 drums of other miscellaneous parts. USA GUILMARTIN, authorized seizure of equipment and equipment seized 8/6/56, turned over to USM 8/7/56. Presently stored International Bonded Warehouse, Miami, Florida. T-1 advised that approximately 20 other shipments have been received in Miami and forwarded to Havana, Cuba. ROTHMAN is reportedly to have made arrangements to ship additional slot machines to Cuba from New Kensington, Pa. Equipment to be shipped from Miami to Havana, Cuba, by Rodville Forwarding Co. USA GUILMARTIN has not rendered decision in regard to prosecutive opinion of ROTHMAN. T-3 advised that equipment should be worth \$250. per completed shell, \$125. per frame, or approximately \$175,000.00 for all equipment. Recovery value, \$175,000.00.

Information received from T-1 on August 29, 1956, was not included in the synopsis of this report, inasmuch as the report had already been typed.
