SAMUEL M. GIANCANA, AKA, AR. DAILY SUMMARY. REFER TO INFORMATION PREVIOUSLY SUBMITTED PERTAINING TO AN INTERVIEW WITH FRANK ANNUNZIO, WHEREBY ANNUNZIO REQUESTED THAT THE INTERVIEW BE HELD IN CONFIDENCE. ACCORDING TO CG 6498 PC, ANNUNZIO WENT DIRECTLY TO JOHN D' ARCO AND REPORTED THE FACT THAT HE HAD BEEN INTERVIEWED BY BUREAU AGENTS REGARDING GIANCANA AND MURRAY HUMPHREYS. NOTED THAT ANNUNZIO HAS BEEN ASSIGNED SYMBOL NUMBER CG 6514 PC, AS A POSSIBILITY OF DEVELOPMENT UNDER THE TOP ECHELON CRIMINAL INFORMANT PROGRAM. IN VIEW OF HIS APPARENT CLOSENESS AND LOYALTY TO JOHN D' ARCO, AND THEREFORE D'ARCO'S ASSOCIATES, IT IS FELT THAT HIS POTENTIAL IS NOW GREATER FOR FUTURE DEVELOPMENT. FURTHER INTERVIEWS WITH ANNUNZIO ARE CONTEMPLATED IN THE NEAR FUTURE. NOTED THAT JOSEPH GLIMCO, CHICAGO TH, WAS INTERVIEWED REGARDING HIS ASSOCIATION WITH GIANCANA AND OTHERS, AND ALTHOUGH HE ADMITTED BEING ACQUAINTED WITH GIANCANA, STATED THAT HE HAS NEVER ASKED GIANCANA FOR ANYTHING, BUT IF GIANCANA ASKED A FAVOR OF HIM, HE, GLIMCO, WOULD DO EVERYTHING IN HIS POWER TO OBLIGE. ARMED AND DANGEROUS.
