PROPOSED MEETING OF TOP HOODLUMS AT MIAMI FEBRUARY 1962.  
CHICAGO PCI GLADYS EBLE ADVISED GIANCANA OBSERVED AT ARMORY  
LOUNGE, FOREST PARK, ILLINOIS 4 PM YESTERDAY. CHICAGO 6486-C\*  
REPORTED DOMINICK "BUTCH" BLASI, BODYGUARD FOR GIANCANA AND  
HY GODFREY, MESSENGER AND BODYGUARD FOR VARIOUS CHICAGO HOODLUMS  
HELD DISCUSSION AT ARMORY LOUNGE LAST EVENING. GODFREY INDICATED  
WELL ACQUAINTED WITH ELMER "DUTCH" DOWLING, LIEUTENANT OF ST.  
LOUIS HOODLUM FRANK "BUSTER" WORTMAN WHO WAS VICTIM OF GANG-  
LAND SLAYING TOGETHER WITH WORTMAN STRONG ARM MAN MEL BECKMAN  
AT BELLVIEW, ILLINOIS MARCH 3, 1962. GODFREY DESCRIBED  
DOWLING AS "SWEETHEART AND GREAT GUY" WHO SPENT EVENINGS IN  
CHICAGO IN THE PAST WITH WORTMAN WHERE "BOTH WOULD LET THEIR  
HAIR DOWN." DESCRIBED DOWLING AS CONCENTRATION CAMP PRISONER  
OF WORLD WAR TWO WHO "BEAT ALL THAT AND CAME OUT TO GET THIS."  
GODFREY INDICATED WAS NOT AWARE OF REASON FOR KILLING BUT  
STATED "BUSTER WILL FIND OUT." FROM TEXT OF CONVERSATION  
NEITHER BLASI NOR GODFREY HAD KNOWLEDGE OF PERSONS INVOLVED  
OR REASON FOR KILLING. BOTH DISCUSSED ADVANCED STATE OF  
SHINGLES "NERVOUS DISORDER" SUFFERED BY MURRAY HUMPHREYS  
AND SUGGESTED IT HAD PROGRESSED TOO FAR FOR TREATMENT.  
GODFREY OF OPINION DISEASE WILL ATTACK VITAL ORGANS AND  
FINISH HUMPHREYS. GIANCANA ARMED AND DANGEROUS.
