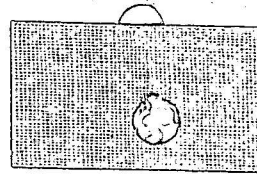
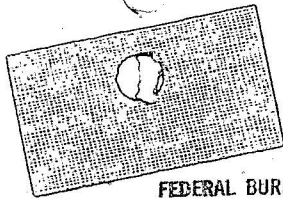

SAM GIANCANA, AKA. AR. DAILY SUMMARY. GEORGE VYDRA, CITY COUNCIL-  
MAN OF BERWYN, ILLINOIS, CHICAGO SUBURB WHO HAS FURNISHED INFORMATION  
IN PAST ADVISED RECENTLY THAT HE HAS BEEN CONTACTED BY ROCKY INFELICE,  
A CLOSE ASSOCIATE OF GIANCANA. INFELICE WANTED TO KNOW IF VYDRA WOULD  
BE INTERESTED IN BUYING THE GUEST HOUSE, WELL KNOWN HOODLUM HANGOUT. (u)

INFELICE ADVISED VYDRA THAT IN EVENT HE WOULD BE SO INTERESTED  
THAT VYDRA WOULD BE ALLOWED TO RUN A GAMBLING GAME WITH CARDS AND DICE  
IN THE GUEST HOUSE ON THE CONDITION THAT HE SPLIT ALL PROFITS FROM THE  
GAMES ON A FIFTY FIFTY BASIS WITH INFELICE AND HIS ASSOCIATES. (u)

INFELICE INDICATED TO VYDRA THAT HE AND HIS ASSOCIATES DESIRE TO  
SELL THE GUEST HOUSE FOR THE REASON THAT THE FACT THAT IT IS A HOODLUM  
HANGOUT IS NOW TOO WELL KNOWN TO LAW ENFORCEMENT AGENCIES. HE TOLD  
VYDRA THAT IT WOULD TAKE SIXTY FIVE THOUSAND DOLLARS TO SWING THE DEAL.  
VYDRA IS CONSIDERING AND WILL REMAIN IN CONTACT WITH THIS OFFICE IN THIS  
REGARD. (u)
