INFORMANT STATED LEWIS ASKED SUBJECT'S HELP IN RECOVERING SOME MONEY, THE DETAILS OF WHICH WERE NOT CLEAR. INFORMANT STATED AFTER LEWIS LEFT, SUBJECT TELEPHONICALLY CONTACTED BEN ANDERSON, SERGEANT, ATLANTIC CITY POLICE DEPARTMENT, AND TOLD HIM HE HAD BEEN VISITED BY LEWIS IN CONNECTION WITH QUOTE THAT SHARP THING END QUOTE. ORMAN THEN TOLD ANDERSON QUOTE YOU PUT SOME HEAT ON AND THEN TELL THOSE FELLOWS WHAT TO DO. THAT FELLOW WILL GO TO TRENTON IF HE DOESN'T GET HIS MONEY BACK END QUOTE.

NEWARK WILL ENDEAVOR TO DETERMINE IDENTITY OF GEORGE LEWIS AND DETAILS OF MATTER <sup>HE</sup> BE DISCUSSED WITH ORMAN.
