Due to the sensitive nature of this Informant, care should be utilized in the dissemination of this information.

DE 919-C\* advised on February 11, 1964, that SAM GIORDANO had recently advised ANTHONY GIACALONE that MARVIN LANE, Commissioner of Police, Warren, Michigan, had advised him that he did not want him in his community any longer, and that he would have to leave his employment with JOHN DUNN because of his association with ANTHONY GIACALONE, MIKE POLIZZI, BILLY GIACALONE, and other people who have been mentioned as members of the Mafia.

According to the Informant, GIORDANO had told LANE that these were the only people that he had known all his life and, therefore, he would continue to associate with them. However, LANE had told GIORDANO that if he did not leave his employment with JOHN DUNN that he, LANE, would see what he could do about getting rid of the Chrysler contract which JOHN DUNN has.
