Set forth below is information furnished by
BU 82-C* concerning events which occurred at Buffalo, New York,
on the dates indicated.

On 6/26/63 CI advised that SCRO had met JERRY
(DOROBIALA) and discussed their various exterminating
contracts. When JERRY raised the question as to how
Attorney AL PACINI was progressing with the corporation
papers, SCRO contacted PACINI telephonically. Upon completing
his call, SCRO told JERRY that PACINI does not need any
additional papers and that he had told PACINI to go ahead.
JERRY reminded SCRO that in three months it would be a year,
apparently referring to the date on which the business enterprise
was initiated.

Later on 6/26/63 JAMES V. LA DUCA discussed with
SCRO problems he was having in the collection of various accounts.
SCRO pointed out that one customer owed them \$600 and \$700
while only owing \$300 to the Frontier (Linen Supply Company).

SCRO and LA DUCA then had an argument, with LA DUCA
claiming that if he does not receive a raise he will have to
sell his house. He pointed out that he has cancelled his life
insurance policies and had to borrow \$1,500 to help with household
expenses. LA DUCA complained of having only one pair of shoes
but at the same time expressed interest in the price of a new
Oldsmobile. SCRO told LA DUCA he should start looking somewhere
else to find why his salary is not sufficient.
