Set forth below is information furnished by BU 82-C* concerning events which occurred at Buffalo, New York on the dates indicated:

August 1, 1963

CI advised that CHARLES A. MONTANA was observed with two men, one of whom was addressed by MONTANA as HOWARD BURTON (PH). MONTANA complained that everyone is complaining about a deal between the three linen companies, which he did not further identify and stated that even the truck drivers are coming in with a rumor of a possible deal.

MONTANA stated that he, SCRO, and BURTON were the only ones who supposedly knew about this and that they had not even told STEVE MAGADDINO about it. He pointed out that they respect MAGADDINO as head of the family and that before any deal can be made they have to talk it over with MAGADDINO.
