On 9/17/63, NY 3586-C-TE advised SA LEONARD MC COY that FRANK CASINO had informed GERARD MOSIELLO aka Jerry Moore, a "Cosa Nostra" member of the GENOVESE "family", working directly under THOMAS EBOLI, acting boss of the GENOVESE "family", that Queens County (NY) District Attorney FRANK O'CONNOR possessed detailed information linking CASINO with the murder of ANTHONY CARFANO. CASINO fears, according to the informant, that JOSEPH VALACHI was the source of the information. CASINO said that O'CONNOR knew "BUSTER from Harlem" was one of the killers of CARFANO and his companion JANICE DRAKE.
