Re Bureau teletype to Miami, 6/18/65, concern-
ing information in CIA report dated 6/14/65. ^{see 90} ^{see 89}

On 6/21/65, U.S. Customs, Miami, advised they
had not received referenced CIA report, but plan an active
investigation on its receipt. Customs said ALEJOS and
GERALD PATRICK HEMMING, American adventurer, had been in
contact. Customs feels certain if and when ALEJOS again
becomes active he will contact EVELIO ALPIZAR PEREZ.
Customs has developed some sources in ALEJOS' world group,
but will depend on FBI intelligence information for
their investigation.

MM 639-S is maintaining close contact with
HEMMING.

EVELIO ALPIZAR PEREZ, key source-Cuban, said
ALEJOS has not recontacted him recently. Miami has
contacted two Cuban mercenaries who participated in
ALEJOS's last plan. These two Cubans were cooperative
in another matter and may cooperate in the future in
this case.

Miami has alerted sources and informants, is

advised.
