BY ROSELLI TO LEDERER SOMETIME DURING THE PERIOD JUNE 8 THROUGH  
17, 1976, LEDERER RECALLED THIS CONTACT. TO HIS BEST RECOLLECTION  
IT CAME FROM THE LOS ANGELES HILTON AND WAS "STRICTLY SOCIAL IN  
NATURE." LEDERER STATED IT WAS NOTHING UNUSUAL FOR ROSELLI TO

PHONE HIM AS HE AND VICTIM HAVE BEEN CLOSE FRIENDS FOR YEARS. LEDERER STATED ROSELLI WAS IN GOOD SPIRITS, APPARENTLY NOT WORRIED ABOUT ANYTHING AND ROSELLI CALLED JUST TO SAY "HELLO." LEDERER SAID HE COULD GIVE NO EXPLANATION OR REASON FOR ROSELLI'S MURDER; HE DOUBTED "THE CHICAGO PEOPLE" PUT THE CONTRACT OUT ON ROSELLI.

CG 9561-CTE ADVISED TODAY AFTER DISCUSSIONS WITH SEVERAL LCN BOSSES IN THIS AREA THE MURDER OF ROSELLI SEEMED TO BE OF LITTLE CONCERN TO THEM. ONE LCN MEMBER INDICATED ROSELLI "HAD IT COMING" AND THAT "HIS TESTIMONY IN SECRECY" HAD ALREADY CAUSED TROUBLE FOR A NUMBER OF PEOPLE. FROM WHAT THIS SOURCE COULD DETERMINE, BOTH THE NEW YORK AND MIAMI "PEOPLE" (LCN MEMBERS) WERE FED UP WITH ROSELLI'S TALKING.

JOEY AIUPPA AND CHARLES NICOLETTI, LCN LEADERS IN THE CHICAGO AREA, WERE LOCATED AND INTERVIEWED. BOTH REFUSED TO MAKE ANY COMMENT ON THE ROSELLI MATTER. ADDITIONAL INQUIRY ON SAMMY "C" VERIFIED WHAT WAS PREVIOUSLY REPORTED. SAM CANZONERI APPEARS TO BE ONLY LCN CONNECTED "HOOD" USING THIS NAME. LIEUTENANT FRUIN, INTELLIGENCE UNIT, CHICAGO PD, ADVISED
