LV SHOULD BE AS HELPFUL AS POSSIBLE TO THE NEVADA GAMING  
CONTROL BOARD IN CONNECTION WITH ITS INQUIRY CONCERNING POSSIBLE  
REVOCATION OF LICENSE CAL-NEVA LODGE. HOWEVER, IN ORDER TO PROTECT  
THE IDENTITY OF OUR INFORMANT, WHO OCCUPIES A HIGHLY SENSITIVE  
RELATION WITH GIANCANA, ONLY LEAD-TYPE INFORMATION SHOULD BE  
FURNISHED TO THE GAMING BOARD AT THIS POINT. IN VIEW OF THE

NOTE: CG topphoodlum Samuel Giancana reportedly visited the Cal-Neva  
Lodge, Lake Tahoe, Nev., 7/27/63, and while there engaged in a fight  
with Victor Collins, bodyguard-business manager of the McGuire sisters.  
Nev. Gaming Control Board (NGCB) investigating matter re possibility  
of revoking Cal-Neva's license. Frank Sinatra is the holder of the  
gambling license at the Lodge. NGCB has requested Bu assistance in  
identifying Collins and his availability for testimony. Due to high  
sensitive nature of Bu's info & danger of exposing our confidential  
source, NK instructed not to make contact with informant at this  
time concerning Collins' availability for testimony. In order to  
protect source, LV authorized to furnish lead-type info  
to NGCB for its assistance in investigation. u
