BEN SWIFT, JR. PAREN. PROTECT END PAREN., A FT. LAUDERDALE
AUTO SALESMAN, ADVISED THIS DATE THAT SAM GIANCANA HAD DEPARTED
THE MIAMI AREA ON AUG. TWENTYTWO, LAST OSTENSIBLY FOR CHICAGO.
SWIFT STATED THAT PHYLLIS MCGUIRE WAS STAYING WITH HER SISTER,
CRIS MCGUIRE, AT CRIS-APARTMENT IN FT. LAUDERDALE AND WAS IN
POOR HEALTH INASMUCH AS HER NERVES WERE VERY BAD. HE ADVISED
HE DID NOT KNOW OF ANY PLANS GIANCANA HAD TO RETURN TO FT.
LAUDERDALE IN THE IMMEDIATE FUTURE. HE STATED THAT SUBJECT AND
PHYLLIS SPENT THEIR ENTIRE TIME IN FLA. AT THE ROLLING HILLS
COUNTRY CLUB, DAVIE, FLA., BUT AFTER THEIR WHEREABOUTS WAS
DISCOVERED BY THE FBI AND LOCAL NEWSPAPER REPORTERS, THEY
AVOIDED THE PUBLIC ROOMS OF THE CLUB AND USED IT ONLY TO SLEEP IN.

SWIFT ADVISED THAT GIANCANA USED SWIFT-S SIXTYTHREE CADILLAC FOR TRANSPORTATION AFTER GETTING RID OF THE LOCAL RENTAL CAR. THE MCGUIRE SISTERS, SUBJECT AND SWIFT PLAYED GOLF EVERY DAY ON LOCAL COURSES, INCLUDING THE PLANTATION GOLF CLUB AND FT. LAUDERDALE GOLD CLUB, FT. LAUDERDALE, FLA., THE DORAL COUNTRY CLUB, MIAMI AND THE PINE TREE CLUB, BOCA RATON. SWIFT ADVISED GIANCANA RIDICULED NEWS REPORTS THAT HE WAS MIXED UPON BAHAMA GAMBLING AND ALSO SCOFFED AT REPORTS THAT HE CONTROLLED GAMBLING IN THE DOMINICAN REPUBLIC, ASSERTING HE WOULD NOT TOUCH IT AS IT WAS A LOSING PROPOSITION. *u*

SWIFT ADVISED THAT HE WAS WITH GIANCANA IN LAS VEGAS SOME MONTHS AGO AND GIANCANA WAS TREATED ROYALLY AT ALL THE HOTELS AND GAMBLING SPOTS. HE STATED THAT FRANK SINATRA, DEAN MARTIN AND EDDIE FISHER MADE A BIG FUSS OVER SUBJECT AND TREATED HIM WITH DEFERENCE. *u*

SWIFT ADVISED GIANCANA IN COMMENTING ON HIS CHICAGO SUIT AGAINST THE BUREAU STATED HE STARTED IT AS A QUOTE GAG END QUOTE AND NEVER EXPECTED IT TO BE AS SUCCESSFUL AS IT WAS AND WAS VERY PLEASED AT THE RESULTS. HE STATED GIANCANA GLEEFULLY SAID HE CAUSED THE BUREAU TO QUOTE COP THE FIFTH END QUOTE WHEN THE SAC, REFUSED TO ANSWER THE COURT-S QUESTIONS. *u*
