ReBulet to Boston dated August 26, 1953 captioned, "SECURITY INVESTIGATIONS - FORMER PRISONERS OF WAR RETURNED TO CIVILIAN STATUS - - SECURITY MATTER - C", which enclosed G-2 Intelligence Summary relative to marked "SECRET".

In accordance with Bureau instructions as set forth in SAC Letter No. 53-58 dated August 25, 1953, Section (J), information concerning the above-named Subject's acceptance of Communist indoctrination during his confinement as a prisoner of war in Korea, as related by in above-referenced G-2 Intelligence Summary, is hereby set forth for the information of the Bureau.

The indices of the Boston Office failed to contain any reference to the above-named Subject.

JFK Act 6 (3)
