Re Chicago letter to Dallas, 9/5/69, (IO) and Dallas letter to Chicago, 9/16/69.

Referenced Chicago letter furnished background information and current activities regarding DOLAN while in Chicago. Information was furnished by ROBERT E. FRANKLIN (protect) presently at 2311 Commonwealth, Chicago, whom DOLAN had lived with at 423 Wrightwood since coming to Chicago in November, 1968.

According to FRANKLIN, DOLAN has since moved from Chicago. FRANKLIN received a letter from DOLAN postmarked August 2, 1969, from Denver, Colorado, with a Reno, Nevada return address of 1275 Fairfield Avenue. It ds to be noted that this address is that of DOLAN's mother. Enclosed in this letter were two keys to the FRANKLIN's apartment at 423 Wrightwood.

It is apparent that DOLAN is not establishing a permanent residence in Chicago. Chicago feels that it would be premature to transfer office of origin at this time in view of information which would indicate DOLAN is no longer in Chicago and in view of information furnished by FRANKLIN that DOLAN travels extensively.

DOLAN SHOULD BE CONSIDERED ARMED AND DANGEROUS AS HE HAS BEEN IDENTIFIED AS A PARTICIPANT IN A ROBBERY WITH FIREARMS AND HAS BEEN KNOWN TO BE IN POSSESION OF FIREARMS IN THE PAST.
