On October 23, 1969, PCI LESLIE ANN FRANKLIN advised DOLAN is presently residing with his brother in a trailer somewhere in Glenview, Illinois.

In addition, informant advised that DOLAN was involved in a robbery of a maintenance man at the Pagoda Motor Inn in Lake Bluff, Illinois, approximately six weeks ago. Informant advised that this individual was robbed of approximately \$5,000 in negotiable bonds and cash.

In view of the fact that the informant has furnished information which would indicate DOLAN is residing within the Chicago Division and in view of the fact that the informant has implicated DOLAN in two armed robberies and two jewelry thefts, it is recommended that the office of origin in this matter be changed to Chicago.

DOLAN SHOULD BE CONSIDERED ARMED AND DANGEROUS AS HE HAS BEEN IDENTIFIED AS A PARTICIPANT IN AN ARMED ROBBERY WITH FIREARMS AND HAS BEEN KNOWN TO HAVE POSSESSED FIREARMS IN THE PAST.
