On 10/28/64 PCI THOMAS JORDAN advised SA GEORGE H. PARFET that he had information that the States Attorney's Office in Chicago, Illinois, had prepared another case to discredit RICHARD CAIN, Chief Investigator for Cook County, Illinois, Sheriff RICHARD OGILVIE. JORDAN stated that the States Attorney's Office intends to break this case publicly prior to the national election on 11/3/64.

JORDAN stated that this case concerned investigation of an abortionist in the Chicago area several months ago. In this matter CAIN's investigators including a policewoman had obtained the services of a pregnant woman who was sent to the abortionist. At the time the operation was to be performed, CAIN's investigators were to enter and arrest the person performing the abortion; however, due to some mixup the investigators arrived there too late and the abortion had been performed.
