#### ADMINISTRATIVE:

On 2/11/65, NY 3936-C advised that the subject is still endeavoring to obtain lemon after entering a guilty plea for Attempted Extortion in Nassau County NY. The informant learned from EDDIE BUFF that GRANELLO has hired an attorney, MOSES WEINSTEIN, who is alleged to have connections with the Queens County and Nassau County District Attorneys Offices. The informant was moded that WEINSTEIN is attempting to contact JOHN ENGLISH, Republician Leader in Nassau County, in an attempt to get GRANELLO a light or suspended sentence.

In view of the close proximity of the informant to the aforementioned situation, this data has not been included in the details of this report.

On 3/15/65, the Identification Division, Federal Bureau of Investigation (FBI) advised that a copy of the subjects arrest record had been furnished to the Customs Agent in Charge, 201 Varick St., NYC, per his request on 3/4/65.

On 3/19/65, Mr. JAMES A. FLYNN, Assistant Customs Agent in Charge, US Customs, 201 Varick St., NYC, advised that his agency recently requested an indentification record for the subject because a customs agent recently observed a 1964 tan Cadillac, Texas Registration VP5381, parked in the vicinity of the subjects residence, 215 Mott St., NYC. According to Mr. FLYNN, this vehicle is registered to EVELYN ROMANO, 7300 Stella Link Rd., Houston, Texas. However, a check by US Customs has reflected that ROMANO is unknown at this address.

Mr. FLYNN advised that his agency has never conducted any investigation relative to the subject. However, his name has come up during investigations of individuals in the Narcotics rackets, who are associates of GRANELLO. Mr. FLYNN stated that his agency is endeavoring to conduct further investigation relative to ROMANO and in the event it is determined that she is associated with GRANELLO, he, FLYNN, will notify the New York Division.

The files of the New York Division reflect that LARRY GOTTLIEB is an associate of various hoodlums in the NYC area including MICKEY D'ALESSIO. In 1961, GOTTLIEB allegedly fingered a burglary of a floral shop owned by his father for the purpose of obtaining money from the insurance company.
