SUMMARY OF INFORMATION

On 16 November 1954, Jack Riffe, Director of the MI Bureau Office,
310 Columbia Building, 10 North Dear St Avenue, Miami, Florida, sent a letter
of introduction concerning [redacted] [redacted], Head of the Communist Party Branch
Front (CPBF), New Orleans Telephone, to Mr. Michael G. [redacted], Acting Manager,
International Rights Bureau, 1127 South Bowers Street, New Orleans, Louisiana.
[redacted] [redacted] Mr. J. J. [redacted] is a Major and holds a Commission
Ranker of the FBI Counterintelligence Section, 45 Army Avenue, New Orleans.
During the last week in November 1954, [redacted] visited [redacted] in his office.
On 27 November 1954, [redacted] again visited [redacted] at his office, and during
the course of their conversation, they discussed Communist agents in Cuba.
[redacted] told [redacted] that there are 25,000 non-Cuban Communist agents in
Cuba, consisting of Russian, Chinese, British, and French-American personnel.
He also stated the USSR in the Crimea is interpreted as obtaining "information"
and a small boat.
