On February 13, 1958, PCI OSCAR LOPEZ RODRIGUEZ, whose identity must be kept confidential and who is in excellent position to obtain photographs of Americans involved in gambling operations in Havana, furnished the enclosed full-face photographs of EDWARD LEVINSON, the present manager of the gambling casino in the Hotel Havana Riviera, and CLIFF JONES, former Lt. Governor of Nevada who is reported to have gambling interests in Las Vegas and who has been publicly named as one of the individuals receiving the concession to operate the casino in the Hotel Havana Hilton. The Laboratory is requested to copy these photographs in a smaller size and furnish two copies of each photograph to Salt Lake City Office for its use and two copies of each photograph to Legal Attache, Havana. *Photograph*
