SUBJECT: AMERICAN GAMBLING ACTIVITIES IN CUBA
ANTI-RACKETEERING

On February 13, 1958, PCI OSCAR LOPEZ RODRIGUEZ, whose identity must be kept confidential and who is in excellent position to obtain photographs of Americans involved in gambling operations in Havana, furnished the enclosed 5x8 full-face photographs of the following individuals:

NAT HARRIS	✓ Photograph

MARVIN KRAUSE	✓ Photograph
EDDIE FEDERICO	✓ Photograph
DUSTY PETERS	✓ Photograph
HENRY TOBINO	✓ Photograph

KRAUSE, SNOW, and HARRIS all are reported by informant to have interests in the casino at the Hotel Capri, Havana.

FEDERICO is known to be a close associate of these individuals but is not known to have any interest in the casino.

PETERS is the collector for the casino in the Hotel Havana Riviera and has been reported by NEIL WALSH, Assistant Manager of the Hotel Havana Riviera, as an individual who does not hesitate to use strong-arm methods to insure collections.

According to source, HENRY TOBINO is reported to be one of the owners and front-men for the soon-to-be-completed gambling casino in the Hotel Deauville in Havana.

The FBI Laboratory is requested to copy these photographs in smaller size and furnish two copies each of each photograph to Miami Office and Legal Attache, Havana.

Discretion should be used in showing these photographs to any informants in order to preclude the possibility of identifying the source of the photographs. Extra copies of this letter have been prepared for possible use by Miami Office.
