Reliable information on July 10, 1973, indicated that captioned individual was in correspondence with the embassy of the Libyan-Arab Republic, Consular Section, Washington, D. C., but the purpose of the correspondence was unknown.

The 1972 Miami Beach City Directory reflects that DAVID YARAS, wife MARILYN A., resides at 4410 Adams Avenue, telephone 538-3255. There was no record of a SCOTT YARAS in this directory. There was a RONALD J. YARAS, part owner of Top Hat Premiums, Inc., Miami Beach, who resided at Apartment 15 at 4011 Meridian Avenue, Miami Beach.

There was no record of Mr. or Mrs. SCOTT YARAS in recent Miami area city and telephone directories.

It is to be noted DAVID YARAS is the subject of Miami File 92-1047, Bufile 92-7599, and he and his wife MARILYN have resided at 4410 Adams Avenue since about 1950. A gambler and bookmaker from Chicago, there are numerous references on DAVID YARAS, FBI No. 655697, and MARILYN YARAS, as well as RONALD J. YARAS and Mrs. DOLORES YARAS, and all these references are of the GIIF and Anti-Racketeering type and there is no information of a security nature. (X)(u)

DAVID YARAS has two sons, RONALD J. and LEONARD YARAS, and as of 1972, RONALD resided at 4071 Meridian Avenue, Miami Beach. (X)(u)

Information obtained in April, 1972, indicated that RONNIE JOEL YARAS had married SANDRA HANDELMAN FINE on March 18, 1972, at Key Colony Beach, Florida. (X)(u)

On August 16, 1973, address report cards (I-53), 1972, on file at Immigration & Naturalization Service (INS), Miami, Florida, failed to reflect any information regarding any individual by the name of YARAS filed in the [Libya] section. (X)(u)

On August 15, 1972, records of the Voters Registration, Metropolitan Dade County, Miami, Florida, contained the following registrations. (X)(u)

DAVE YARAS, a white male born 38 years before in Illinois, had registered to vote in Dade County on January 15, 1951, listing his address as 4410 Adams Avenue, Miami Beach, Florida. He had come to Miami Beach a year before from Chicago, and was a restaurant owner. (X)(u)

MARILYN YARAS, same address, white female, housewife, born 35 years before in Illinois, had registered on the same date. (X)(u)

There was also DOLORES YARAS, born January 6, 1938, in New York, who had lived at 1520 Jefferson Avenue. (X)(u)
