The period of investigation in this matter is quite extended. It will be pointed out, however, that investigation has been conducted in this matter and has been reported in Dallas letter to the Director dated 11/12/63, which requested Bureau authority to interview subject. This authority was granted by the Bureau under date of 12/11/63. Subsequent investigation in this matter has been delayed inasmuch as the agent to whom this case was assigned has been employed full time in the investigation of the LEE HARVEY OSWALD case at Dallas.
