FOUR, NINETEEN THIRTYSIX, AT WELLSBURG, WEST VIRGINIA, TO MARTHA,  
AND HAD ONE SON, ROGER, BORN MAY FIFTEEN, NINETEEN FORTY. BELLO  
FOR MANY YEARS OPERATED SALOON AND GAMBLING HOUSE, STEUBENVILLE,  
WITH "SLIM" BREWER AND ON OTHER SIDE OF ESTABLISHMENT, PROSTITUTES  
WERE OPERATED FOR BREWER. BELLO REPUTED EXPERT DICE MAN, AND CARD  
DEALER, WELL ACQUAINTED IN U. S. GAMBLING CIRCLES. ARRESTED MARCH

TWENTYFIVE, NINETEEN FORTYONE STEUBENVILLE PD, CHARGE ASSAULT AND BATTERY, DISMISSED. BELLO UTILIZED AS INFORMANT CRIMINAL ACTIVITIES MID NINETEEN FORTIES. IN NINETEEN FORTYEIGHT ADVISED HE HAD BEEN ACTIVE GAMBLING CIRCLES JACKSONVILLE AND MIAMI, FLORIDA AREAS THAT YEAR. BUREAU ADVISED BY LETTER FEBRUARY TWENTY, NINETEEN FIFTY, BELLO LOCATED NORTH CAROLINA BUT MAINTAINED RESIDENCE STEUBENVILLE., SERVICES DISCONTINUED AS RARELY IN CINCINNATI DIVISION.
