On June 5, 1961, it was learned by the Pittsburgh Office that ANGELA BARBARA of Apalachian, New York, the daughter of Mrs. JOSEPH BARBARA, would be married to Dr. ANTHONY MESSANA of Grosse Point, Michigan, on June 8, 1961, at the St. Cair Montefalco Catholic Church, Detroit, Michigan. It was also learned that the reception would be held on that same date at the Hillcrest Country Club, Mt. Clemens, Michigan. The doctor is an osteopath intern at the Highland Park Osteopathic Hospital.

The aforementioned informant advised that ROY VEY, another supervisory official at the North Star Cement Block Co., is very annoyed about questions asked of him by Internal Revenue Service Agents and is particularly annoyed with the fact that his interviewers want a cost of living figure from him and found it hard to believe that his mother loaned him the money to put into the North Star operation.

Information Pertaining to Legitimate Financial Activities

The Phoenix Motel, Monroeville, Pa.

PG T-6 has advised that he has recently heard rumors among Pittsburgh area gamblers to the effect that ARTHUR D. "ARCHIE" NELSON wants to sell the Phoenix Motel at Monroeville, Pa., for an unknown reason. He said the heart attack suffered by NELSON during May, 1961, is believed by these gamblers to have been staged to prepare a plausible reason for him to sell a profitable business. They are convinced the alleged heart attack is a "phony." According to the informant, the same gamblers have stated that they understand that "the boys from New Kensington" are interested in buying the Phoenix Motel. He believes this reference can only mean that the MANNARINO brothers personally are interested in the purchase or that it will be referred to someone fronting for them.
