The Pittsburgh "Sun-Telegraph," Blue Streak Edition, dated July 15, 1958, carried an article on Page 3 regarding the failure of LA ROCCA to answer the Government's invitation to his preliminary naturalization hearing. The article described LA ROCCA as the one-time boss of the East Liberty numbers racket.

A similar article appeared in the Final Edition of the Pittsburgh "Post-Gazette" on July 16, 1958, and described LA ROCCA as one of the few who escaped a round-up of sixty ganglords at a rural retreat in upstate New York last fall.

Information Regarding Subpoena for La Rocca to Appear Before United States Senate Labor Rackets Committee

ALBERT DI MEOLO, United States Marshal for the Western District of Pennsylvania at Pittsburgh, advised SA VOEGE on July 1, 1958, that he had received a subpoena to serve to SEBASTIAN JOHN LA ROCCA to appear before the Senate Select Committee on Improper Activities in the Labor Management Field. He stated further that LA ROCCA's close associate, MIKE GENOVESE, had already been served with a subpoena to appear before that committee and that he had been contacted in this regard at Archie's Automatic Car Wash, 8050 Bennett Street, Pittsburgh, by a Deputy United States Marshal on June 20, 1958. He explained that both subpoenase advise the recipients or their lawyers to contact telephone number Capitol 4-3121 at Washington, D. C., for further advice as to when to appear before this committee.

DI MEOLO was recontacted on August 25, 1958, and August 26, 1958, by SA VOEGE at which time he advised that he had learned nothing new concerning the present whereabouts of LA ROCCA and that he was still interested in learning the present whereabouts of GABRIEL MANNARINO, a close associate of LA ROCCA and a Pittsburgh top hoodlum, who has also "disappeared" from the Pittsburgh vicinity.
