In accordance with Bureau instructions, a thorough review of all information in the files of the Pittsburgh Office relating to SEBASTIAN JOHN LA ROCCA has been conducted. This review has encompassed information developed in our Criminal Intelligence Program and that information gleaned from informants, as well as information being received on a continuing basis from a highly confidential source at LA ROCCA's place of business, the North Star Cement Block Company, 12 Mc Candless Avenue, Pittsburgh. This source was activated on 2/7/61.

In answer to specific questions set forth in reairtel:

1. LA ROCCA is not presently the subject of a substantive case, nor is any process--local, state or Federal, currently outstanding against him.
2. At present the subject is seeking to squelch any publicity concerning himself, according to informants. A slight possibility exists that employees may become involved in ITSP violations in view of the fact that LA ROCCA prefers to hire state parolees as truck drivers at his cement block plant. Pittsburgh will remain alert to discover any vulnerable area wherein there is a possibility of establishing a violation within the Bureau's jurisdiction against LA ROCCA.

3. The Immigration and Naturalization Service at Pittsburgh, although it maintains an active interest in LAROCCA and his activities, no longer has an open or pending file in this respect. LA ROCCA has resisted successfully all efforts to effect his deportation and has withdrawn his petition for naturalization.

The Immigration and Naturalization Service verified the aforementioned on 2/13/61.

The Internal Revenue Service at Pittsburgh

LA ROCCA presently resides at Ingomar, Pa., approximately fifteen miles from Pittsburgh, in a home which could not be built today for \$125,000. He purchased it for \$42,500 and is known to have put at least \$40,000 into the house and surrounding property. He drives a new Fleetwood Cadillac and his wife has a new Oldsmobile. LA ROCCA's adopted son is in attendance at Valley Forge Military Academy, Wayne, Pa., where the minimum tuition, room and board is \$2,225 annually.
