We are going to make an extended stay in Europe, and I am anxious to lecture and write, partly to cover expenses, but also to meet students and teachers at the universities and education.

I don't know when we shall be in the German Democratic Republic -- it could be in August, but it is my impression that there is not much activity at the universities (or elsewhere?) during the vacation period.
