Dear Gertrude:

Sue and I send warmest regards to Stefan and yourself, and look forward to seeing you one of these days in the coming summer or fall.

We sail from Montreal on May 17th, direct to Gdynia in Poland. We stop over a few days in Warsaw, but proceed to Moscow about June 1st. We are invited there as guests of the Association of Film Makers of the USSR. I am not yet sure of further plans, except that we shall be back in Moscow for the International Film Festival in July.

We are going to make an extended stay in Europe, and I am anxious to lecture and write, partly to cover expenses, but also to meet students and teachers at the universities and educational institutions, and to talk about various aspects of American theatre and film, history and culture.

I don't know when we shall be in the German Democratic Republic-- it could be in August, but it is my impression that there is not much activity at the universities (or elsewhere?) during the vacation period.

We are going to be in Czechoslovakia in September, and could probably come to Germany after that if it turned out to be a more suitable time.


