Enclosed for the Bureau and Miami are copies of a letterhead memorandum (LHM) captioned "Unidad Nacional Revolucionaria" and dated as above at Los Angeles, setting forth information obtained from and involving a veiled threat to FILIBERTO RIVERO, radio commentator on Latin American news and recently divorced husband of cinema actress JUDY CANOVA, by SA WILLIAM J. MC CAULEY. Similar information, though in less detail, was received from JOE DAVANON of CIA, Los Angeles (who had been contacted by RIVERO by SA MC CAULEY on 6/14/65, and was related to CSIA 3184-S (Anti-Subversive Detail of the Los Angeles Police Department) that same day. RIVERO was advised that if he felt himself to be in any danger he should contact the Los Angeles Police Department. He replied that his concern was not so much for his safety, as he receives threats against himself once or twice a month, but that JOSE IGLESIAS, national leader of UNARE, appears to have effected persons whom he has always considered to be his friends in such a way that it would appear they have been transported into a state of near fanaticism.

RIVERO confided that the friend who informed him of GARCES' and his associates' revised consideration of him is a woman, visiting in Los Angeles, whose husband, a former good friend of GARCES, is presently in jail in Cuba, serving a 30 year sentence for anti-CASTRO activity. In view of this circumstance, he said, he does not wish to make the friend's identity available at this time. He added that he will prepare a list of names and addresses of GARCES' associates in UNARE,
