Your file (with copies made where appropriate, will return today). 2. Anne Buttimer's file 3. Joe Freeman's file from legislative Archives 4. Best Evidence 5. Death of a President 6. The Day Kennedy was Shot 7. Volume VII of the HSCA Report B. Accomplished so far: 1. Meeting with Tammi, Anne, Joe and Doug to compare notes and set priorities. 2. Chart with Parkland witnesses -in progress. 3. Chart with Bethesda witnesses-in progress. 4. Chart with "missing medical documents"-in progress 5. Spoke to General Counsel at Bethesda (an old friend of mine, who called to say hello). He is almost positive that they turned over everything to Archives, but will double check for me. C. Priorities: 1. Locate "Dallas" Death Certificate requested by Battocletti. After reviewing the materials above, I am convinced this document exists or did once. I have asked Steve Tilley to conduct a search for this Death Certificate, not the one from Bethesda. Both Phil and I recall seeing this document up there, although it is possible we are thinking of the Bethesda one. If Tilley can't find it, we need to look at the USSS, since the paper trail seems to end with them. I have already briefed Joan on this. 2. Locate Treatment Notes from Parkland, also requested by Battocletti. Other than the reference from the Swinford FBI report, I can find no mention of these records. It is possible that SA Swinford was given bad information from Mr. Price (Parkland Administrator), who may have been referring to the handwritten notes made by the Doctors at 4PM, after JFK's body was removed. I will continue to look for references to these records in the open and referred sources. 3. Other Medical "records". a. the "working papers" of the HSCA Medical Panel-- Joe and I will look for. b. the Casket Team Report by Sam Bird-- Lifton says he got a FOIA copy from MDW, I can't find it in the Database. It may be in the JFK Presidential Library Material - - I will check there. c. Locate the "Bird Tape". I will ask Anne to confirm Bird's Address and phone #. Lifton interviewed Bird in the mid-70's and got no where. Bird suffered a head wound in Viet Nam and has little memory of the Kennedy Funeral. But if he has the tape hopefully we can get a copy. 4. Continue work on Charts of witnesses. 5. There are several documents on the HSCA collection that deal with medical records that are referred or postponed. I will visit Legislative Archives this week to investigate.
