Kennedy Records Collection Act of 1992, 44 U.S.C. 2107, Section 6(1)A] came by today to "assess" some of the HSCA materials currently on-site at ARRB. Contrary to my expectations, they spent almost all their time (they stayed almost three hours) in the Security Classifed Testimony (as opposed to Security Classified Files) boxes -- materials they already have at CIA (except for the Azcue and Mirabal testimony *). While here, they stamped with "CIA has no objection..." the testimony of Michael James (Box 4, re: Nosenko), Yuri Nosenko (Box 4, 5/30/78 and 6/19/78 testimony, not his 6/20 testimony), J.Lee Rankin (Box 10) and E. Howard Hunt (Box 10). It seemed as if they were unsure as to how to attack the Security Classified Files boxes. [Screened by: NARA RD-F on October 12, 2016 according to the John F. Kennedy Records Collection Act of 1992, 44 U.S.C. 2107, Section 6(1)A] also suggested they were working on the Security Classified Testimony boxes first because they know we have an interest in getting as much as possible before the Board and -- since the CIA had already accorded the testimony some level of review at some point in the past -- believed they could process the testimony for us relatively quickly. *The
