Subject: HSCA documents/this week's meeting

HSCA Privacy Records There are two more reviewed privacy-related documents in the pile in your office. This brings the total to 22. Of these 18 are Ferrie-related, 3 are VA (two regarding Ivo Tucci's medical records, 1 regarding an OCR summary of John David Hurt's VA files) and one is an NOPD arrest record for Thomas Beckham (re: attempt to marry a 14 year-old, the girl's name -- and her mother's -- is redacted. I need you to: 1) confirm your intention that these documents go before the Board on Tuesday afternoon (as envisioned by today's pre-meeting meeting), 2) do whatever you have to do in the computer to assign these documents to the meeting (if I can do this without you, let me know), 3) confirm the "yellow" status of the documents, so I can do the appropriate cover sheets for the Board meeting. P.S. VA has responded to us on the records we sent them. Copy of letter is in your box. Finck document This is the six-pager that you got Barry Harrelson's sign-off on. I reviewed it and forwarded it to you, envisioning a green consent agenda item for the meeting. David conceptualizes it differently: he sees it as CIA returning a referral to NARA and thus doesn't view it as something the Board needs to or can act upon. He does see us sending it out to interested parties and claiming ownership of its release that way. So this one, pending further input, is out of your pile (though it's still in the Review Track) and not intended for processing by the Board. P.S. In the latest issue of PROBE, this document rears its ugly head again, in the Finck article, where NARA's handwritten RIF (incorrect, actually) is used to suggest Finck worked for the CIA. Security Classified Testimony See earlier E-Mail on this. In the pre-meeting meeting, it seemed to me as if David saw these as analogous to the Finck document -- these were referrals, the CIA has cleared them for release, so they don't need to go to the Board; they can just be sent down to Matt and Kris to process... although I may have misunderstood him on this. The only outstanding question is other-agency equities. I reviewed the James Michael testimony and found none that I could recognize. I reviewed the Nosenko 6/19/78 testimony and found a possible NSA equity on page 18. I haven't gotten to the others yet. Redactions in HSCA Payroll documents It was brought to my attention this past week that David does not envision us making the redactions on these or any HSCA documents. He indicated he intended to talk to Steve Tilley about this (presumably soon). This is a change from the earlier discussion we had about it. I've kicked out the final determination forms for all the HSCA documents processed at the Oct. meeting. But I need to chat with you and verify closure on what comes next in terms of turning them over to NARA. I'm sure you have a million other things going on. Advise/acknowledge when possible.
