Review Board's representative in the call: Dave MontagueDescription of the Call Subject: Possibly Final Attempt (5th) To Interview Patsy Paschall At Home For An InterviewSummary of the Call: I called Patsy Paschall's residence today and spoke with her husband Clyde. I informed him of the fact that I have left at 11 messages since Thanksgiving at either home or work for Patsy and she has not returned my calls. I also informed him that as a federal investigator I am authorized to review assassination-related materials and was hoping that Patsy would have been more cooperative. He doesn't think she has sold the film yet but thinks she is dealing with another person (besides Mark Oakes) re: its final disposition. Clyde said he gave her my previous message and that she said she is not going to make any long distance calls to Washington, DC. I asked if that was her only response to why she has not called and he said she didn't really concentrate on the issue because she was trying to talk about something else at the time. I reemphasized that the ARRB is not a research entity and Patsy needs to have a discussion with me re: her film and other possible records. Clyde said the best time to reach her is between 7-7:30 Central time. I also informed him that I wished she had communicated that information to us via mail or other media and that I have made numerous attempts to contact her including sending her a packet of information about the Review Board. I ended the conversation saying that I may attempt to try her in the morning but that I was not going to call her at work again and that she has had ample opportunity to discuss the film with me if she was serious about helping the efforts of the Review Board. \* Paschall previously requested that I call her at a later date in order for her to have time to review the received letter and ARRB material in preparation for our discussion. Paschall said she will be glad to discuss anything regarding our interest in material and/or information. At that time Paschall mentioned that she has information pertaining to her and Marina Oswald.
