Description of the Call Date: 02/27/96Subject: Confirmation On Location Of Carl EardleySummary of the Call:After numerous attempts to get information through various individuals within the Civil Division of DOJ, Betty McKenna who used to work with Eardley agreed to talk to me about him. McKenna said she knows he had a stroke about 1 year ago, is probably around 90 years old and lives in Bethesda, Maryland. My previous investigation resulted inthree possibilities one of which should be alive in Bethesda; I found no death record for him.McKenna did some checking for me and found that Eardley left government service on 09/02/77. Between 1966-67 Harold B. Sanders, Jr. was the Assistant Attorney General for the Civil Division and was succeeded by Edwin L. Weisl, Jr. who held office from 1967-69. Eardley was the Acting Assistant Attorney General during the interim. She recommended that if I want more specific information on his role with the assassination over the years that I should contact David J. Anderson of DOJ. Anderson was very young at the time but worked with Eardley and would probably be quite helpful.\* After our conversation I contacted Anderson and he has no idea where such information may be and could offer no point of reference toward that end.
